

RULES

FOR ERASMUS STUDENTS IN THE UNIVERSITY CAMPUSES for the 2023/2024 academic year

I. The deadline for accommodation in the university campus is as follows:

1. First semester - until October 01st ;
2. Second semester - until February 20th .

II. Total to be paid :

1. First semester:

- BGN 5.84 per day - rent and consumables for September, the total amount for the month is calculated proportionally to the days of September starting from the day of accommodation;
- BGN 180,00 rent and consumables for October;
- BGN 180,00 rent and consumables for November;
- BGN 180,00 rent and consumables for December;
- BGN 180,00 rent and consumables for January;
- BGN 15,00 deposit;
- BGN 10.00 accommodation fee;
- BGN 6,00 for a chip.

BGN 751.00 total amount for the semester, which will be increased by the rent for September calculated from the date of accommodation

Monthly rent and consumables are due by the 10th of the current month.

2. Second semester :

- BGN 180,00 rent and consumables for February;
- BGN 180,00 rent and consumables for March;
- BGN 180,00 rent and consumables for April;
- BGN 175,00 rent and consumables for May;
- BGN 175,00 rent and consumables for June;
- BGN 15,00 deposit;
- BGN 10.00 accommodation fee;
- BGN 6,00 for a chip.

BGN 921.00 total amount due for the semester.

Monthly rent and consumables are due by the 10th of the current month.

Note : In case of an increase in the price of energy, the rent could be subject to an increase.

All applicants wishing to be accommodated in the university campus shall be required to pre-pay by bank transfer the amount of BGN 180.00, which after the conclusion of the Student boarding house tenancy Agreement shall be used as a guarantee for the fulfillment of the tenant's obligations under the Agreement. This amount is non-refundable in case the student does not arrive.

Erasmus students are required to complete their documentation with the Treasurer, the unit host, within five working days of their accommodation.

After the expiration of the contract, the Student boarding house tenancy Agreement can be extended by an annex upon room availability.

At the end of the semester, the campus committee shall inspect the condition of the room and produce a written report. In case of good faith performance of the rental agreement, the security deposit will be refunded by bank transfer to students coming from an EU Member State. In the case of students coming from a non-EU country, the security deposit is refundable in cash or by bank transfer, bank charges being borne by the tenant. In case of damage to the property, the amount of the refund will be deducted, calculated at market prices. Tenants sharing an apartment shall be jointly and severally liable for the property in the common areas.

III. Accommodation :Students will be accommodated in single rooms in the university campus, Block 2.

Note : The amounts are calculated in Bulgarian leva (BGN) and converted into euro (EUR) at the BNB exchange rate.
